ORDINANCE NO. 7394.

An Ordinance adopting the Report of the City Surveyor in the matter of the proposed lateral extension of Vancouver Avenue in that part of the City of Portland formerly known as Albina, from the north line of Russell street to the south line of Morris street.

THE CITY OF PORTLAND DOES ORDAIN AS FOLLOWS:

SECTION 1;- Whereas the Common Council deeming it expedient to extend, and establish a lateral extension of Vancouver Avenue from the north line of Russell street to the south line of Morris street by widening said Avenue ten feet on each side and making the side lines 35 feet distant from and parallel with the center line of Vancouver Avenue, did on the 20th day of January 1892, direct the City Surveyor to survey the same, mark the boundaries thereof, and make his report of such survey containing a plat thereof and a full and perfect description of such proposed street extension and the boundaries thereof and of the portion of each tract or lot or part thereof to be appropriated to public use for such proposed street extension and the City Surveyor having made such survey, report and plat and filed the same in the office of the Auditor and Clerk on the 1st day of January 1892, and said report being satisfactory to the Common Council

NOW THEREFORE, The said Report of T.M. Hurlburt City Surveyor in the matter of the proposed extension of the said Vancouver Avenue is hereby adopted of which said report the following is a copy, to-wit;-

TO THE HONORABLE THE COMMON COUNCIL OF THE CITY OF PORTLAND, Or.

GENTLEMEN;-

In pursuance of a Resolution adopted by your Honorable Body at your meeting of Jan. 20th A.P. 1892, directing me to survey and mark the boundaries of a proposed lateral extension of Vancouver Avenue as follows: By widening said Avenue ten feet on each side and making the side lines 35 feet distant from and parallel with the center line of Vancouver Avenue from the north line of Russell street to the south line of Morris street. I have surveyed and marked the boundaries of the proposed lateral extension of Vancouver Avenue and herein submit my report containing a plat of said survey.

The proposed lateral extension of Vancouver Avenue is 20 feet being 10 feet on each side of said Avenue, and is more particularly bounded and described as follows, to-wit;-

Beginning at a point in the north line of Russell street which point is 10 feet east of the east line of Vancouver Avenue thence northerly parallel to and 35 feet easterly from the center line of Vancouver Avenue to the south line of Morris street; thence westerly along the south line of Morris street 70 feet; thence southerly parallel to and 35 feet westerly from the center line of said Vancouver Avenue to the north line of Russell street; thence easterly along said north line of Russell street 70 feet to place of beginning.

The proposed lateral extension of Vancouver Avenue will include and necessitate the appropriation to public use for such Avenue the following described parcels or tracts of land, to-wit:-

The west 10 feet of Lot 1 Blk.1 Railroad Shops Addition; containing 476 square feet and owned by W.A.Wells.
