ORDINANCE No. 183962

* Authorize an Intergovernmental Agreement with Portland Development Commission for \$6,800 for a professional services contract to review the Bureau of Development Services' Fiveyear Financial Plan. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

- 1. Portland Development Commission (PDC) has secured a consultant to review the financial plan of the Bureau of Development Services (BDS).
- 2. Given the prolonged recession and the highly volatile economic environment, the above effort is necessary to provide Council and BDS the assurance that the current BDS financial plan is reasonable.
- 3. The funding for this payment is authorized in FY 2009-10 Spring BMP.
- 4. The City wishes to enter into an Intergovernmental Agreement substantially similar to Exhibit A (attached), with PDC to provide funding for the above consultant services.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to execute an intergovernmental agreement for \$6,800 in one-time funds with PDC in conformance with the agreement substantially similar to Exhibit A attached to this ordinance.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the General Fund within 15 days upon the passage of this ordinance.

Section 2. The Council declares that an emergency exists to avoid a delay in providing funding to PDC; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
