

ORDINANCE No. 183976

\* Authorize acceptance of \$20,000 in grant funding from the Oregon Department of Justice for the state-wide Domestic Cannabis Eradication/Suppression Program (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The U.S. Drug Enforcement Administration provides funding to the Oregon Department of Justice, Criminal Justice Division in support of Domestic Cannabis Eradication/Suppression Programs in Oregon.
2. The Oregon Department of Justice, Criminal Justice Division has awarded the City of Portland, Oregon Police Bureau a \$20,000 grant for the Domestic Cannabis Eradication/Suppression Program (DCE/SP). This continues program funding since 1995.
3. The DCE/SP grant will reimburse the City a maximum of \$20,000 for overtime and operational expenses associated with eradication missions.
4. Authorization of the Letter of Understanding between the City and the Oregon Department of Justice is conditioned upon both parties' agreement to the attached Letter of Understanding Amendment #1.
5. The grant period is January 1, 2010, to December 31, 2010.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City a grant from the Oregon Department of Justice in support of Domestic Cannabis Eradication/Suppression Programs in Oregon in the amount of \$20,000.
- b. The Mayor and City Auditor are hereby authorized to authorize this Letter of Understanding and Amendment #1 substantially in accordance with the Agreement attached as Exhibit A.
- c. The FY 2010-11 budget is hereby amended as follows:  
GRANTS FUND  
Fund 217001  
Business Area – PL00  
Bureau Program Expenses – 20,000
- d. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.


