#### 1) Legislation Title:

\* Authorize acceptance of \$20,000 in grant funding from the Oregon Department of Justice for the state-wide Domestic Cannabis Eradication/Suppression Program (Ordinance)

#### 2) Purpose of the Proposed Legislation:

The City of Portland, Oregon Police Bureau has been awarded a grant from the Oregon Department of Justice, Criminal Justice Division to support the Bureau's marijuana eradication efforts. The City will enter into a Revenue Contract with the State of Oregon. The Letter of Understanding and Amendment obligate the roles and responsibilities of both parties. The grant period is January 1, 2010, to December 31, 2010.

#### 3) Revenue:

The Letter of Understanding (LOA 2010-105) stipulates the State will reimburse the City for approved personnel overtime and operational expenses not to exceed \$20,000.
