

ORDINANCE No. 183984

*Accept a grant in the amount of \$100,000 from Oregon Watershed Enhancement Board for Tryon Creek Confluence Habitat Enhancement (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. BES applied to OWEB, through its Special Investment Partnership (SIP) program, for a grant in the amount of \$100,000 for Tryon Creek Confluence Habitat Enhancement on May 20, 2009; and
2. OWEB has notified the City of Portland that it will award a grant for Tryon Creek Confluence Habitat Enhancement to BES in the amount of \$100,000.

NOW THEREFORE, the council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from Oregon Watershed Enhancement Board (OWEB) for Tryon Creek Confluence Habitat Enhancement in the amount of \$100,000 and to execute a grant agreement in substantially the same form of the attached exhibit for this purpose.
- b. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.


