1) Legislation Title:

*Accept a grant in the amount of \$100,000 from Oregon Watershed Enhancement Board (OWEB) for Tryon Creek Confluence Habitat Enhancement (Ordinance)

2) Purpose of the Proposed Legislation:

Authorize the City to accept grant funding from OWEB to fund a project to enhance 4.5 acres of riparian and off-channel fish habitat at the Tryon Creek Confluence with the Willamette River.

3) Revenue:

Passing the ordinance gives BES the opportunity to accept \$100,000 in grant funding from OWEB for floodplain and riparian habitat restoration. The origin of these funds is State of Oregon lottery. Grant funds will be expended and reimbursed in FY 10/11. These funds have already been included in the FY 10/11 budget during the Production phase of budget development.

The grant from OWEB requires a 25% match. Local match in the amount of \$25,000 will be provided in the form of salary, benefits, and services in the FY 2010/11 proposed budget of the Bureau of Environmental Services. Matching funds are available in the Sewer System Operating Fund, Bureau of Environmental Services, WBS element E08958.
