

## ORDINANCE NO. 183988

Authorize contract with Murray, Smith & Associates for the design of the Forest Park Low Tank project (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland Water Bureau (PWB) requires consultant services for the design of the Forest Park Low Tank project. This new tank will add redundancy and reliability to the Northwest Hills service area and the additional storage will meet the needs of local residents for at least 20 years. The location and elevation of the tank will allow lower elevation services to be fed from a more efficient location.
2. The formal Request for Proposal was utilized for this contract in accordance with the City Code for Professional Services Contracts.
3. \$168,596, or approximately 31.6%, of the contract dollars will be awarded to State of Oregon certified Minority, Women, and Emerging Small Businesses.
4. The not to exceed value of the contract is \$533,857. The Confidence Level for this contract is Optimal. Funding for the project is available in the FY 2010-11 Budget and will be requested in the FY 2011-12 through FY 2013-14 Budgets.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and Auditor are authorized to execute on behalf of the City a contract with Murray, Smith and Associates, Inc. in a form in accordance with the contract attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver checks chargeable to the Water Fund, Account 521000, when demand is presented and approved by the proper authorities.
