#### **BACKGROUND ANALYSIS** 7.

In 2007, the Office of Neighborhood Involvement (ONI) put out an RFP for Graffiti Removal Services and selected the Youth Employment Institute (YEI) to provide graffiti removal services on private property upon referral. YEI also provides a substantial amount of support for the weekend cleanups and volunteer training and coordination. ONI entered a grant agreement to continue their services in FY 2009-10. YEI has provided consistent services and ONI is requesting authorization to extend the grant agreement June 30, 2011 to maintain these services in FY2009-10. Similar to our other grant agreements, the ordinance also authorizes future amendments by the ONI Director based upon funding allocated in a budget adopted by Council.

The ordinance to authorize this agreement is filed as an emergency ordinance to allow immediate execution of the amendment and avoid interruption in the graffiti removal services.

#### FINANCIAL IMPACT 8.

ONI's budget for FY2010-11 includes \$175,000 for services provided by YEI. The agreement may be amended in future years by the ONI Director based on funding allocated in a budget adopted by Council. No new revenue will be generated.

#### RECOMMENDATION/ACTION REQUESTED 9.

Approve the ordinance and allow the ONI Director to enter an amendment to the grant agreement between the City of Portland and the Youth Employment Institute to extend graffiti removal services through June 30, 2011.
