

Ord. No. 16879.

An Ordinance providing for the change of the names of certain streets in the City of Portland.

The City of Portland does ordain as follows:

Section 1: That the names of the streets within the corporate limits of the City of Portland be and the same are hereby changed as provided in Section 2 of this Ordinance and the said street shall hereafter be known <sup>by the names</sup> as provided in said Section.

Section 2: That Milton street in Willamette, Albion Addition to Albina, Gay's Addition to Albina, Park Addition to Albina and Nut Grove, all now in the City of Portland, be changed and hereafter known as Ainsworth Avenue.


Section 3: Nothing contained in this ordinance shall in any way effect the validity of any proceeding now pending for the improvement, opening, laying out, extending or widening of any of the streets above mentioned, or for the changing or establishing of grades thereon, but such proceedings shall continue and be completed as though the names of such streets had not been changed.
