**1) Legislation Title:**

\* Authorize an intergovernmental agreement between the City, the Tri-County Metropolitan Transportation District and Oregon City (Ordinance)

**2) Purpose of the Proposed Legislation:**

It is the intent of this agreement to assign one or more Oregon City Police Officers to Transit Police. Transit Police is managed by the Portland Police Bureau, and staffed by officers from several jurisdictions. Oregon City will pay the salaries, overtime, insurance, retirement and other benefits and indirect (overhead) charges. Oregon City will invoice TriMet for services provided by Oregon City. Future staffing levels may be adjusted by agreement of the City of Portland, Oregon City and TriMet under the authority of the commander of the Transit Police Division.
