

## ORDINANCE No. 184003

Amend contract with Black Helterline LLP for outside legal counsel. (Ordinance; amend Contract No. 38066)

The City of Portland ordains:

### Section 1. The Council finds:

1. The City required the services of outside legal counsel to work with on immigration issues relating to H-1B and other immigration forms.
2. The law firm of Black Helterline LLP, (Counsel) agreed to provide these services by Legal Services Agreement No.C38066, dated June 18, 2008.
3. Due to the nature of the work being performed, and the number of incidents requiring immigration related forms and procedures, it is estimated that Counsel will exceed the currently contracted amount.

NOW, THEREFORE, the Council directs:


- a. The City Attorney is authorized to extend Legal Service Agreement NoC38066, dated February 21, 2006, for an additional \$20,000, for a total not to exceed \$44,000.
- b. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement.


