

**ORDINANCE No. 184005**

\*Authorize a contract with Washington Audiology Services, Inc. for Hearing Conservation Program Services for a total amount not to exceed \$250,000. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The City of Portland requires that employees exposed to high noise level averages at or above 85 decibels will have their hearing tested and receive appropriate training annually in accordance with OR OSHA Hearing Conservation Program requirements.
2. The services were advertised and four proposals were received. A selection committee comprised of five City of Portland personnel and a minority community member reviewed and scored the proposals in accordance with PCC 5.68.
3. The contract, attached as Exhibit A, is for a five year term commencing July 1, 2010 and ending June 30, 2015.
4. Sufficient funding resides in OMF Risk Management fund 521000 beginning in FY 2010-2011.

NOW THEREFORE, the Council Directs:


- a. The Chief Procurement Officer is authorized to enter into a contract with Washington Audiology Services, Inc for Hearing Conservation Program Services substantially in conformance with Exhibit A attached.
- b. The Mayor and the Auditor are hereby authorized to draw and deliver checks payable to Washington Audiology Services, Inc. chargeable to the OMF Risk Management fund 521000, in an amount not to exceed \$250,000 when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because safety requirements mandate that Hearing Protection Services be available on a continuing basis, and the current contract will expire at the end of this fiscal year; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.


