

**ORDINANCE No. 184010**

- \* Authorize contract with Burlington Water District for fire prevention, suppression and emergency response services for FY 2010-11. (Ordinance; Contract No. 30001370)

The City of Portland ordains:

Section 1. The Council finds:

1. Burlington Water District has requested that the City provide it fire prevention, suppression and emergency response services for its property on the terms and conditions described in Exhibit A, attached to this Ordinance.
2. The City, through Portland Fire & Rescue, is willing to provide these services to Burlington Water District, as requested and on the terms and conditions set forth in Exhibit A.

NOW, THEREFORE, the Council directs:

- a. That the Mayor and City Auditor are authorized to execute an Agreement for fire prevention, suppression and emergency response services with Burlington Water District, for the term beginning July 1, 2010 and continuing through June 30, 2011 for the sum of \$103,358.00, paid by Burlington Water District, on the terms and conditions set forth in the Agreement, a copy of which, marked Exhibit A, is attached to this Ordinance.

Section 2. The Council declares that an emergency exists because the current agreement expired on June 30, 2010; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.


