ORDINANCE No. 184019

*Authorize an Intergovernmental Agreement with Multnomah County and accept a grant in the amount of \$175,000 for Communities Putting Prevention to Work. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

- 1. The Bureau of Transportation submitted a proposal in the amount of \$200,000 to Multnomah County to be included in the County's application to the Centers for Disease Control and Prevention for a Communities Putting Prevention to Work American Recovery and Reinvestment Act of (ARRA) 2009 grant.
- 2. Multnomah County was awarded a \$7.5 million grant from the Centers for Disease Control and Prevention. The County has notified the City of Portland that it will receive a grant for the Communities Putting Prevention to Work project to the Bureau of Transportation in the amount of \$175,000.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from Multnomah County for the Communities Putting Prevention to Work project in the amount of \$175,000 and to execute an intergovernmental agreement in substantially the form of the attached exhibit for this purpose.
- b. The FY 2010/11 is hereby amended as follows, with the balance to be appropriated in FY2011/12.

c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
