

**ORDINANCE No. 184024**

Authorize a contract with the lowest responsible bidder for the UIC Remediation Project Phase 2 Project No. E09180 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. A number of UICs (sumps) in east Portland do not meet Oregon DEQ requirements for minimum groundwater separation. These UICs must be modified, or the City will be subject to fines for non-compliance.
2. The Bureau of Environmental Services has designed and is ready to bid a construction project that will remediate these non-compliant facilities.
3. The estimated cost is \$1,050,000. Level of confidence is high. Funds are available in the Sewer System Operating Fund, FY 2011 Budget, Bureau of Environmental Services, WBS Element E09180.C60.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs and Auditor are authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
