It is my understanding that Transportation is considering an alternative half-street improvement along NE Alberta St. from 76th Avenue to 79th Avenue in the absence of petition support on the south side of the street. To facilitate the planning of the improvement, Fire was asked to render an opinion on the fire access issues associated with the improvement, specifically, should parking be allowed along the street.

A study of the neighborhood access shows that this neighborhood has very little in the way of a street grid system. Street grids allow for alternative emergency access) opportunities. In the case of a street that is impassible by congestion, illegally parked vehicles, construction etc., a gridded street system allows a second, third, or even fourth route to the emergency scene. There is no access from the north of Alberta, from west of 76th, and the access from the south is limited due to the fact that many of the streets are four blocks long without cross street connections.

Further, half street improvements increase the difficulty in making ninety degree turns onto cross streets because of the narrower driving widths, which equates to restricted maneuvering.

For these reasons, Fire asks that no parking be posted on the north side of the half street improvement along NE Alberta St. Fire sees no reason at this point to restrict parking along the south, unimproved side of the street.

### **Purpose of Substitute:**

The Substitute effects the following:

- v. 4934 NE 78th Avenue (NE Alberta Street frontage)
- vi. 4933 NE 78th Place (NE Alberta Street frontage)
- vii. 4932 NE 78th Place (NE Alberta Street frontage)

viii. 4929 NE 79th Avenue (NE Alberta Street frontage)
