

ORDINANCE No. 184040

* Authorize a grant to provide the Portland Schools Foundation \$100,000 for support of strategic efforts to meet the goal of reducing the drop out rate by half by 2013 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds that:

1. The City of Portland recognizes that the city's future economic and social well-being are dependent upon ensuring a strong education foundation for all our city's youth; and
2. The City of Portland is concerned about the number of students dropping out of high school, with only 51%-65% of local students graduating on time; and
3. The City recognizes the mission of the Portland Schools Foundation to catalyze the support needed to assure a world-class education for all Portland students, and further recognizes the need for this crucial work to be sustained; and
4. On September 2, 2009, Council unanimously approved Ordinance #183160 authorizing a grant of \$100,000 to the Portland Schools Foundation to support its efforts to reduce the drop out rate; and
5. The Portland Schools Foundation is a central partner in the strategic efforts of the Portland Multnomah Education Cabinet, whose goal is to cut the local drop out rate in half by 2013, as per the substantially similar grant agreement in Exhibit A.

NOW, THEREFORE, the Council directs:

- a. The Mayor is authorized to enter into a Grant Agreement, as outlined in form substantially in accordance with the agreement attached as Exhibit A, at a cost not to exceed \$100,000.
- b. The Mayor and Auditor are hereby authorized to draw and deliver payment chargeable to the Fiscal Year 2010-11 Adopted Budget.

Section 2. The Council declares that an emergency exists because any delay in providing grant funding to Portland Schools Foundation would harm the public interest; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
