

ORDINANCE No. 184060

*Pay claim of Alta Hamilton. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. Alta Hamilton has filed a property damage claim against the City for damages suffered in a motor vehicle accident involving PBOT on May 6, 2010.
2. The claim has been investigated by Risk Management Services. The investigation indicates there is risk the City may be found liable. Therefore, in order to avoid the risk of an adverse jury award, we feel it is prudent to compromise the claim at this time.
3. Risk Management Services recommends the claim be compromised for the total sum of \$11,194.61, subject to the claimant providing the City with a release in a form to be approved by the City Attorney. Risk Management has previously paid \$676.32 to Alta Hamilton for her insurance deductible and out of pocket rental car expenses not covered by her State Farm policy.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to draw and deliver a check in the amount of \$10,518.29 made payable to State Farm Insurance.
- b. Risk Management Services will execute a payment authorization in the amount set forth in sub-paragraph (a) above.

Section 2. The Council declares that an emergency exists in order to avoid undue and costly delay in settling this claim; therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
