## ORDINANCE No. 184066

Authorize a contract and provide payment for construction of the Solids Lagoon Reconstruction Project Phase 2 at the Columbia Boulevard Wastewater Treatment Plant Project No. E07145 (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Columbia Boulevard Wastewater Treatment Plant (CBWTP) treats the City's wastewater in accordance with State of Oregon Department of Environmental Quality (DEQ) issued NPDES permit requirements
2. The solids lagoon is an integral part of the wastewater treatment plant and serves to provide emergency storage of solids, allows for operational flexibility, and affords additional destruction of solids thus increasing dewatering and reducing biosolids hauling costs. The solids lagoon needs to be lined to assure prevention of groundwater contamination and upgraded to meet current practices and regulatory design standards
3. This project is the second of a five phase effort to line the lagoon, construct upland landscaping and enhance an adjacent wetland. The first phase constructed a dike across the mid point of the lagoon. The second phase will line the south half of the lagoon while keeping the north side in operation.
4. The established cost is \$ 5,900,000. The level of confidence is high. Funds are available in the Sewer System Operating Fund, FY 2010- 2011 Budget, Bureau of Environmental Services, Cost Center, WBS Element E07145.

NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute a contract with the lowest responsible bidder for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
