ORDINANCE NO. 118101

An Ordinance abolishing 17 positions, creating 13 positions, adjusting rates of pay authorizing call shifts for sick leave, and transferring appropriations in order to implement reorganization of the Bureau of Fire effective April 2, 1964 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that the Chief of the Bureau of Fire has recommended a plan for reorganization of the Fire Bureau to be effective April 2, 1964; that this plan includes closing Engine Company Number 1 Station, reassigning three positions to Engine 29 and abolishing 12 positions, creating 10 additional positions for Fire Prevention, abolishing 1 position of Deputy Chief, reducing the number of fire fighting districts from 5 to 4 with the elimination of 3 positions of the Battalion Chief, making salary adjustments for Assistant Chiefs and Staff Captain, and purchasing certain items of equipment and operation and maintenance necessary for the changed operation; that said plan has been approved by the Commissioner in charge of the Bureau of Fire; that savings resulting from the operation of said plan between April 2 and June 30, 1964 will provide funds for purchase of necessary equipment and operation and maintenance; that said plan will increase the utilization of personnel and facilities in the Bureau of Fire; and that the proposed reorganization should be authorized without delay; now, therefore, the following positions in the Bureau of Fire, Fighting Division (825.110), are hereby abolished effective April 2, 1964:

> 1 Deputy Chief 3 Battalion Chiefs 2 Fire Captains 2 Fire Lieutenants 9 Fire Fighters

The following positions are hereby created in the Bureau of Fire at the salary ranges listed below, effective April 2, April 2, 1964:

Executive and Clerical Division (815.110)1 Typist Clerk--Salary Range No. 14 Fire Alarm and Telegraph Division -- (820.110) 2 Fire Alarm Operators -- Salary Range No. 31 Fire Fighting Division -- (825,110) 1 Staff Fire Captain within the class of

Salary Range No. 35 Fire Captain --

Fire Prevention Division-(830.110)

2 Sr. Fire Inspectors- Salary Range No. 33 7 Fire Inspectors - Salary Range No. 31 Section 2. The Salary Range assigned to class of Assistant Chief is hereby changed from Range 42 to Range 44.

Section 3. Payment for call shifts for sick replacement in the Fire Alarm Division is hereby authorized, not to exceed 300 hours per fiscal year.

Section 4. In order to provide funds in the proper accounts to implement the reorganization plan in the Bureau of Fire, appropriations are hereby transferred as follows:

Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: That it is necessary to authorize the reorganization in the Bureau of Fire as provided in Sections 1 through 4 of this ordinance without delay in order that arrangements for said reorganization may be made prior to the effective date; therefore, an emergency hereby is declared to exist, and this ordinance shall be in force and effect from and after its passage by the Council.
