ORDINANCE No. 119970

An Ordinance accepting a sewer easement through Lot 4, Block 3, Orchard Park, for the S.W. 52nd Avenue and S.W. Lowell Street Sanitary Sewer System, granted by Sol Till and Elizabeth Till, and declaring an emergency.

The City of Portland ordains:

Section 1. That the following described easement be and is hereby accepted for sewer purposes:


The south 10.0 feet of the west 20.0 feet of Lot 4, Block 3, Orchard Park in the City of Portland, County of Multnomah and State of Oregon.

(Granted by Sol Till and Elizabeth Till, 4109 S.W. 52nd Avenue, \$5.00 being the amount to be paid for said easement.

Section 2. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this Ordinance, and consent to sewer easement, placed on record.


Section 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any undue delay in making this right-of-way a matter of record; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
