

ORDINANCE No. 122813


An Ordinance authorizing the drawing and delivery of a warrant in the amount of \$32.00 in payment for an easement, granted by Martin K. Piltz and Patricia L. Piltz for the S.W. Taylor's Ferry Sanitary Sewer System No. 4, chargeable to the Contributions and Advances to Improvement Districts (3835), providing for repayment and declaring an emergency.


The City of Portland Ordains:

Section 1. The Council finds that the City of Portland by Ordinance No. 121959, passed by the Council February 23, 1966, accepted a sewer easement more particularly described by said Ordinance No. 121959, and by reference herein made a part of this ordinance; that said ordinance authorized payment in the sum of \$32.00, payable to Martin K. Piltz and Patricia L. Piltz, and that pursuant to said Ordinance No. 121959, the easement and Consent to Sewer Easement were duly recorded by the City Auditor in the Multnomah County Deed Records; that request for payment has been made by Mr. Piltz and that said payment should now be made; now therefore, the Mayor and Auditor hereby are authorized and directed to draw and deliver a warrant in the sum of \$32.00 payable to Martin K. Piltz and Patricia L. Piltz, 2906 S.W. Spring Garden Road, said warrant to be drawn against and charged to the Contributions and Advances to Improvement Districts (3835); and the Mayor and Auditor are further authorized and directed to draw and deliver a warrant in the sum of \$32.00, payable to said Contributions and Advances to Improvement Districts (3835) said warrant to be drawn against and charged to the S.W. Taylor's Ferry Sanitary Sewer System No. 4 fund, when created.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this; That it is in the public interest that all financial obligations of the City be paid without delay; therefore an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
