ORDINANCE No. 122820

An Ordinance accepting a sewer easement through a portion of Lot 7, Werlock, in Multnomah County, for the S.W. Taylor's Ferry Sanitary Sewer System No. 8, granted by Lloyd A. Babler and Rita Babler, Husband and Wife; and Carl M. Halvorson and Cathryn V. Halvorson, Husband and Wife, and declaring an emergency.

The City of Portland Ordains:

Section 1. That the following described easement be and is hereby accepted for sewer purposes:

A portion of Lot 7, Werlock being a strip of land 15.0 feet in width. 7.5 feet on each side of the following described center line and its northeasterly and southwesterly extensions.

Commencing at the Initial point of Werlock, a plat duly recorded in the Plat Records of Multnomah County, Oregon, thence S. 880 41, 45" E. along the northerly line of said Werlock a distance of 1285.90 feet to a point lying on the easterly line of Werlock, said point being also the northeasterly corner of Lot 7, Werlock; thence S. 00 10' 25" E. along the easterly line of Werlock a distance of 43.97 feet to the point of beginning of the center line to be described; thence S. 52° 44' 40" W. along said center line a distance of 230.36 feet to a point lying S. 0° 10' 25" E. 187.60 feet from the northwest corner of Lot 7, Werlock, in the City of Portland, County of Multnomah and State of Oregon.

Section 2. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this Ordinance placed on record.

Section 3. Inasmuch as this Ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any undue delay in making this right-of-way a matter of record; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
