

ORDINANCE NO. 125206

An Ordinance amending Ordinance No. 125125, passed August 9, 1967, relating to transfers of appropriations within the funds of the City of Portland for the fiscal year 1966-67, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 125125, passed August 9, 1967, made certain transfers of appropriation within the various funds of the City of Portland for the fiscal year 1966-67; that it is necessary to amend said ordinance both to include account adjustments made by the Auditor and to correct a typographical error in the amount transferred to the Auditor's Office in the prior year appropriations; now, therefore, Ordinance No. 125125, passed August 9, 1967, is hereby amended to read as follows:

Section 1. The Council finds that certain appropriations within the General Fund, Fire & Police Disability & Retirement Fund Street Lighting Fund, Water Fund, Water Construction Fund, Golf Fund, Sewage Disposal Fund, Exposition-Recreation Fund, Parking Meter Fund, General Fund (Prior Year), Sewage Disposal Fund (Prior Year) and Parking Meter Fund (Prior Year) must be supplemented to meet the total expenditure requirements for the fiscal year 1966-67; that certain other appropriations within those funds have balances which can be made available by transfer; and that such transfers should be made; now, therefore, transfers within the General Fund, Fire & Police Disability & Retirement Fund, Street Lighting Fund, Water Fund, Water Construction Fund, Golf Fund, Sewage Disposal Fund, Exposition-Recreation Fund, Parking Meter Fund, General Fund (Prior Year), Sewage Disposal Fund (Prior Year) and Parking Meter Fund (Prior Year), are hereby made to and from accounts as specified below and in the amounts indicated:




