ORDINANCE No. 130256

An Ordinance accepting a sewer easement through a certain tract of land in Section 18, T.1N., R.2E., W.M., Multnomah County, Oregon for the Storm Sewer in N.E. 55th Avenue, N.E. Skyport Way and Private Property, granted by Skyport Properties of Oregon, Ltd., and declaring an emergency.

The City of Portland ordains:

Section 1. That the following described easement be and is hereby accepted for sewer purposes:


A strip of land in Section 18, T.1N., R.2E., W.M., and the Anthony Whitaker Donation Land Claim and the City of Portland, County of Multnomah and State of Oregon, being 10.0 feet in width and lying 5.0 feet on each side of the following described center line:

Commencing at the point of intersection of the north line of N.E. Skyport Way with a line drawn 10.0 feet west of and parallel to the division line between the east and west halves of said Anthony Whitaker D.L.C.; thence N. 0° 00' 50" W. along said parallel line a distance of 92.26 feet to the point of beginning of the center line to be described; thence N. 24° 00' 50" W. a distance of 121 feet more or less to the point of intersection with the center line of the Columbia Slough and there terminating. (Granted by Skyport Properties of Oregon Ltd., % William Wright & Associates, 3635 Hood Street, Portland, Oregon 97201. ³)


Section 2. That the City Auditor be and he is hereby directed to have this easement, as described in Section 1 of this Ordinance and Consent to Sewer Easement placed on record.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any undue delay in making this right-of-way a matter of record; therefore, an emergency is hereby declared to exist and this Ordinance shall be in force and effect from and after its passage by the Council.
