## **ORDINANCE No.** 184085

\* Amend contract with the Tri-County Metropolitan Transportation District of Oregon for certain contract employees to work for Portland Streetcar (Ordinance; amend Contract No. 51530)

The City of Portland ordains:

Section 1. The Council finds:

- 1. On January 10, 2001, City Council On January 10, 2001 the City Council passed Ordinance No. 175241 authorizing an Agreement with the Tri-County Metropolitan Transportation District of Oregon (TriMet) for the provision of certain contract employees to work for Portland Streetcar (Personnel Agreement No. 51530).
- 2. On January 10, 2001, City council passed Ordinance No. 175240 authorizing an Agreement with TriMet to provide funding assistance for the operation and maintenance of the Portland Streetcar System (Funding Agreement No. 51529).
- 3. On May 2, 2001, the City Council passed Ordinance No. 175540 authorizing an Agreement with TriMet for the provision of other services as needed by the City for the operation and maintenance of the Portland Streetcar (Other Services Agreement 51545).
- 4. The Agreements have been amended from time to time.
- 5. TriMet and Portland Bureau of Transportation have agreed to a new amendment to Contract No. 51530 that would extend the term of the Personnel Agreement to June 30, 2012, and desire to implement it at the same time as Funding Agreement No. 51529 is implemented.

NOW THEREFORE, the Council directs:

- a. The Mayor and the Auditor are hereby authorized to execute an Amendment to Contract No. 51530 with the Tri-County Metropolitan Transportation District of Oregon, substantially in accordance with the amendment attached to the original of this Ordinance and, by reference, made a part thereof.
- b. The Mayor and City Auditor are hereby authorized to draw and deliver checks to TriMet chargeable to the Transportation Operating Fund, Fund 200000, Business Area TR00.

Section 2. The Council declares that an emergency exists because a delay in implementation would adversely impact the required schedule for TriMet's provision of the contract employees needed for the operation of Portland Streetcar; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.
