ORDINANCE No. 184088

*Amend contract with Parsons Farnell & Grein, LLP for outside legal counsel
(Ordinance; amend Contract No. 30001303)

The City of Portland ordains:

Section 1. The Council finds:

1. The City requires the services of outside legal counsel for expert legal work in the matter of Portland v. Kerr Contractors, Inc., MCCC Case No. 0810-14326.
2. The law firm of Parsons Farnell & Grein, LLP, agreed to provide these services by Legal Services Agreement No. C30001303.
3. Due to the nature of the work involved it is necessary to increase the amount of this contract to pay for services already received and to continue work on this project.

NOW, THEREFORE, the Council directs:

- a. The City Attorney is authorized to extend Legal Service Agreement No. C30001303, to provide for representation by outside counsel in an additional amount of \$25,000, for a total not to exceed \$75,000.
- b. If applicable, the provisions of City Code Chapter 5.68 are waived.
- c. The Mayor and Auditor are authorized to draw and deliver warrants in payment of legal services provided under this Legal Services Agreement.

Section 1. The Council declares that an emergency exists in order to pay for legal services already provided in the matter of City v Kerr; therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
