ORDINANCE NO. 135833

An Ordinance amending Section 10 of Ordinance No. 134079, which amended the Code of the City of Portland to delete the requirement of conditional use of property in C2, M3, M2 and M1 Zones for automobile service stations, in order to extend the effective date of said ordinance to June 30, 1973, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Ordinance No. 134079, passed by the Council February 17, 1972, amended various sections of Title 33, Planning and Zoning, of the Code of the City of Portland, Oregon, and repealed certain sections therein, so as to delete the requirement of conditional use of property in C2, M3, M2 and M1 Zones for automobile service stations, and fixed a special effective date of August 3, 1972; that Ordinance No. 135022, passed by the Council August 3, 1972, amended said Ordinance No. 134079 to extend said effective date to January 31, 1973; that in order to allow sufficient time for the Planning Commission to consider proposed regulations for service stations, it has been recommended by the Commission and approved by the Commissioner in charge thereof that the effective date of said Ordinance No. 134079 be extended to June 30, 1973; now, therefore, Section 10 of Ordinance No. 134079, passed by the Council February 17, 1972, hereby is amended to read as follows:

Section 10. This ordinance shall take effect on June 30, 1973.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: In order to become effective before January 31, 1973; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
