

ORDINANCE NO. 136089

An Ordinance amending Title 3, Administration, of the Code of the City of Portland by adding a new Chapter 3.94 creating an Office of Planning and Development to supervise the Bureau of Buildings and the Bureau of Planning, designating functions and providing for line of authority, amending Section 33.08.040 of Title 33, Planning and Zoning, of the Code to conform to changes in Title 3, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that a management structure is needed in the city government to provide communication, coordination and direction for the community development process in Portland; that the management structure recommended by the Mayor as Commissioner in charge of community development necessitates establishing an Office of Planning and Development to supervise the Bureau of Buildings and the present Office of the Planning Commission within the city government; that the Office of Planning and Development would also provide the necessary support for the Planning Commission and coordinate the activities of other agencies in Portland involved in community development; and that the Office of Planning and Development would be supervised by a Planning and Development Administrator. Further, that Section 33.08.040 of the City Code should be amended to reflect that the City Planning Director will no longer be the designated secretary of the Planning Commission; now, therefore, Title 3, Administration, and Title 33, Planning and Zoning, of the Code of the City of Portland are hereby amended by adding a new Chapter 3.94 which shall be numbered and titled and shall read as follows:

CHAPTER 3.94

Office of Planning and Development

Section

3.94.010 Creation and Functions

3.94.020 Line of Authority

3.94.010 Creation and Functions. There is hereby established an Office of Planning and Development with a Planning and Development Administrator in charge and such other employees as the Council may provide. The Office of Planning and Development shall supervise the Bureau of Buildings and the Bureau of Planning (previously known as the Office of the Planning Commission) and shall provide staff

support to the Planning Commission. The Office of Planning and Development shall also provide communication and coordination among other agencies in Portland involved in planning and development.

3.94.020 Line of Authority. Assignment of the Office of Planning and Development by the Mayor to any department shall automatically assign the Bureau of Buildings and the Bureau of Planning, together with the Planning Commission, for administration and support services.

Section 2. The Council finds that establishment in Section 1. above of the Office of Planning and Development necessitates amendment of Section 33.08.040 of the Code of the City of Portland so as to change the assignment of duties of the Secretary of the Planning Commission; now, therefore, Section 33.08.040 of the Code of the City of Portland is amended to read as follows:


33.08.040. Records. The Planning and Development Administrator shall provide the Commission with a secretary who shall keep an accurate record of all proceedings of the Commission. The Commission shall, on the first day of April of each year, make and file an annual report on transactions and accomplishments during the preceding year with the Auditor who shall transmit such reports to the Council.


Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: in order to increase efficiency by coordinating functions of the Bureaus mentioned above without undue delay; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
