ORDINANCE No. 135139

An Ordinance authorizing execution of quitclaim deed to Johnson & Nielsen Co. Inc. for a portion of vacated NE 52nd Avenue, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds that Johnson & Nielsen Co. Inc., 3910 SE 65th Avenue, Portland, Oregon 97206, has requested that, in order to clear title to land reverting to it through the vacation of a portion of NE 52nd Avenue, which was vacated by Ordinance No. 135811, passed by the Council December 27, 1972, the City execute a quitclaim deed to it releasing any interests of the City in said property but reserving all easements for utilities established in said vacating ordinance; that it has been recommended by the City Engineer and approved by the Commissioner in charge that such quitclaim deed be executed; now, therefore, the Mayor and Auditor hereby are authorized to execute on behalf of the City a quitclaim deed to Johnson & Nielsen Co. Inc. for a portion of vacated NE 52nd Avenue, said deed to be substantially in accordance with Exhibit A attached to the original only of this ordinance and by this reference made a part hereof.

Section 2. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland, in this: In order to clear title to the land, as set forth in Section 1 hereof, without unnecessary delay; therefore, an emergency hereby is declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
