

**ORDINANCE No. 184095**

\*Authorize contract with Con-way Properties, Inc. for Sunday Parkways sponsorship (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Vision for the Portland Bureau of Transportation (PBOT) calls for a balanced, multi-modal transportation system where residents will have a broad range of safe and convenient transportation options and will frequently walk, bicycle, carpool, or ride public transit as their first choice of transportation.
2. Sunday Parkways is the concept of opening up a network of streets once a week to encourage healthy, active walking and cycling and has proven to be an effective means of promoting active transportation in several cities across the world. In 2009, three Sunday Parkways events drew over 50,000 participants and garnered significant media coverage.
3. The City of Portland and its partners are implementing five Sunday Parkways events in 2010, which will promote walking and bicycling in Portland. The final Sunday Parkways of 2010 will be held on September 26th in Northwest Portland, adjacent to Con-way Properties.
4. The City of Portland and Con-way Properties desire to enter into a contract for use of Con-way Properties' parking lot during the Sunday Parkways event on September 26, 2010.
5. The contract has been reviewed by the City Attorney.

NOW, THEREFORE, the Council directs:

- a. That the Commissioner-in-Charge and the Auditor are authorized to sign this contract substantially in accordance with the contract attached to the original of this ordinance and by reference, made a part hereof.

Section 2. The Council declares that an emergency exists because the Northwest Portland Sunday Parkways event will be held on September 26, 2010 and both parties desire to move forward immediately. Therefore, this Ordinance shall be in full force and effect from and after its passage by the Council.
