This contract is one of several evaluation measures that will test the effectiveness of the curbside food scrap collection pilot project. The various evaluation data points and findings will be collected and reported back to council in together.

If emergency, why does this need to take effect immediately:

Any delay in proceeding with this ordinance would delay Campbell DeLong Resources, Inc. from being able to conduct primary research in a timely fashion and would harm the City's ability to obtain relevant feedback from those that participated in the City's food scrap curbside collection pilot project.

## 4. History of Agenda Item/Background:

In March 2010, BPS awarded a contract to Campbell DeLong Resources, Inc. to provide public opinion research services in regards the 2,000 households involved in the pilot of a curbside food scrap collection project. The original contract scope of work was to deliver one post implementation focus group. The pilot project tested the delivery of two distinct recycling, garbage, yard debris and food waste service packages to residents. Combining these two distinct groups into one focus group would compromise the research results. The addition of one focus group will allow the Contractor to facilitate two post pilot implementation focus groups where participants are divided based on the type of service they received. In addition, the participant data is supplied by the recycling and garbage service providers. This data source is heavily skewed to home owners. In order to receive feedback/opinions from a better representative sample, two improvements are recommended—1) matches site addresses to phone numbers, and 2) add a third focus group with renter participants.

Approve a \$13,000 contract amendment between the City of Portland Bureau of Planning and Sustainability and Campbell DeLong Resources, Inc. for public opinion research services.
