ORDINANCE No. 145050

An Ordinance authorizing acceptance of a sewer easement right of way for S.W. FLORENCE LANE - S.W. ORCHID STREET AND PRIVATE PROPERTY STORM AND SANITARY SEWER SYSTEM granted by Leisure Resources, Inc. etal, at no cost, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Right of way is required for construction of the S.W. FLORENCE LANE - S.W. ORCHID STREET AND PRIVATE PROPERTY STORM AND SANITARY SEWER SYSTEM.
- The above mentioned grantor has conveyed the required right of way to the City at no charge to the City.

NOW, THEREFORE, the Council directs:

The acceptance of a sewer easement over the following land is authorized:

Parcel I - The north 15 feet of the west 45 feet of Lot 3, Hilary Heights, Washington County, Oregon.

Parcel II - The west 5 feet of Lot 3, Hilary Heights, Washington County, Oregon.

Parcel III - The east 10 feet of Lot 4, Hilary Heights, Washington County, Oregon (Granted by Leisure Resources, Inc., 7100 S.W. Hampton, Suite 103, Tigard, Oregon 97223).

b. The Auditor shall record in the appropriate deed records, documents of title as necessary for purchase of this right of way.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the sewer easement might jeopardize the City's ability to acquire the property at no cost; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
