An Ordinance accepting four sewer easements for the SW ARNOLD CREEK SANITARY SEWER PROJECT, granted by G. Eldon Fix and Dorothea W. Fix, Mattie L. Herod, William M. Herod, James W. Herod and Mildred F. Herod, Patrick L. Keene and Maureen G. Keene, Dorrell L. Martyn and Evelyn Ramona Martyn, authorizing total payment of \$4398.00 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- Right of way is required for construction of the SW Arnold Creek Sanitary Sewer Project.
- G. Eldon Fix and Dorothea W. Fix, Mattie L. Herod, William M. Herod, James W. Herod and Mildred F. Herod, Patrick L. Keene and Maureen G. Keene, Dorrell L. Martyn and Evelyn Ramona Martyn have conveyed the required right of way to the City for the total sum of \$4398.00.

NOW, THEREFORE, the Council directs:

a. That the following described easements are hereby accepted for sewer purposes:
