

ORDINANCE No. 151847

151847

An Ordinance amending Chapter 16.42, Bicycles, of the Code of the City of Portland, by repealing Sections 16.42.010, Registration required; 16.42.020, Registration file to be kept by Chief of Police; and 16.42.030, Sales to be reported, which relate to registration of bicycles, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the existing bicycle registration program, established by Sections 16.42.010, 16.42.020 and 16.42.030 of the Code, does not best serve the needs of bicycle owners, bicycle sales businesses, or the Bureau of Police and should, therefore, be replaced by a more modern crime prevention program directed at reducing bicycle thefts and improving the process of returning stolen bicycles to their owners.
2. That the Bureau of Police has developed and implemented such a program.
3. That, therefore, the existing bicycle registration program is no longer necessary, and therefore, that Sections 16.42.010, 16.42.020 and 16.42.030 of the Code should be repealed.

NOW, THEREFORE, the Council directs:


- a. That Chapter 16.42, Bicycles, is hereby amended by repealing Sections 16.42.010, Registration required, 16.42.020, Registration file to be kept by Chief of Police, and 16.42.030, Sales to be reported.

Section 2. The Council declares that, in order to better protect the public peace and safety, an emergency exists and this Ordinance will be in force and effect from and after its passage by the Council.
