

ORDINANCE No. 184125

Authorize a contract and provide for payment to furnish replacement dump trucks at \$1,190,000.
(Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The CityFleet Division of the Bureau of Internal Business Services replaces all City vehicles based on an annual replacement plan.
2. CityFleet has reviewed the standard replacement schedule and the condition of the 12-15 yard dump trucks used by Bureau of Environmental Services and Water Bureau.
3. It has been determined that four dump trucks need to be replaced for BES - vehicles #86257, #86258, #86389, and #86488, and three for Water Bureau, #984201, #994505, and #994206.
4. The estimated cost of replacing these trucks is \$170,000 each, or \$1,190,000 for the seven dump trucks.
5. The City now desires to purchase these vehicles.

NOW, THEREFORE, the Council directs:

- a. The Chief Procurement Officer is authorized to issue a purchase order for these vehicles in accordance with City Code 5.33.
- b. The Mayor and City Auditor are hereby authorized to pay for said purchases from the CityFleet Replacement Fund.
