## ORDINANCE No. 184143

\*Authorize contract with Centennial School District for Afterschool At-Risk Meal and Snack Program (Ordinance)

The City of Portland ordains:

## Section 1. The Council finds:

- 1. Portland Parks & Recreation is a sponsor of an Afterschool At-Risk Meal and Snack Program. Through this program, children enrolled in afterschool education or enrichment programs in low-income areas receive free nutritious meals and snacks. Program sponsors are eligible for federal reimbursement of costs.
- 2. The success of the at-risk program, according to a 2009 Oregon Hunger case study, is "integrally tied to the availability, vitality and quality of afterschool programming."
- 3. Portland Parks & Recreation's community centers offer a variety of afterschool programs. During a pilot program in May and June 2010, meals were served to children enrolled in afterschool programs at St. Johns Community Center.
- 4. Many of Portland Parks & Recreation's other community centers are in areas eligible for the program. Through a vended meal agreement with Centennial School District, Portland Parks & Recreation will provide meals to children at St. Johns Community Center, as well as additional sites.

## NOW, THEREFORE, The Council Directs:

- The Portland Parks & Recreation Director is hereby authorized to enter into, and a. make payment on, a vended meal agreement with Centennial School District in a form substantially in accordance with the agreement attached as Exhibit A.
- Section 2. The Council declares that an emergency exists in order to avoid delay after-school meal program service; therefore, this Ordinance shall be in force and effect from and after its passage by Council.
