

ORDINANCE NO. 184157

- \* Accept and appropriate grant in the amount of \$224,000 from the State of Oregon Housing and Community Services Department to assist low-income renters who face barriers to accessing housing and receive payment. (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. Portland Housing Bureau (PHB) requested a renewal of the Tenant Readiness Rent Guarantee Grant from State of Oregon Housing and Community Services Department (OHCS).
2. OHCS has notified the City of Portland that it will award a grant for the Tenant Readiness Rent Guarantee to PHB in the amount of \$224,000.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the OHCS for the Tenant Readiness Rent Guarantee Grant in the amount of \$224,000.
- b. The FY 2010-11 budget is hereby amended as follows:

GRANTS FUND

Fund 217

Business Area HC00

Bureau Program Expense: (\$224,000)

- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because delay in funding would interrupt the Portland Housing Bureau's ability to provide services under this Agreement; therefore, this ordinance shall be in force and effect from and after its passage by Council.
