* Accept a grant in the amount of \$280,453 and appropriate \$145,059 for Fiscal Year 2011 from the United States Department of Justice, Office of Justice Programs, National Institute of Justice for the FY 2010 Solving Cold Cases with DNA grant program (Ordinance)

2) Purpose of the Proposed Legislation:

To accept a grant award from the United States Department of Justice (USDOJ), Office of Justice Programs, National Institute of Justice in order to enhance the work of the Police Bureau's Cold Case Homicide Unit's ability to review cases, inventory and review evidence and submit DNA evidence to the Oregon State Police Crime Laboratory (State Crime Lab) for forensic analysis.

The USDOJ will reimburse the City for four limited term part-time investigators, one 0.5 FTE limited term public safety aide, one limited term, part-time community outreach coordinator, 1.0 FTE State Crime Lab Forensic Scientist I dedicated to reviewing Police Bureau Cold Case Homicides and crime lab program supplies not to exceed the award amount of \$280,453.

The City will incur benefit expenses (TriMet payroll tax and TRIP incentive) related to the limited term employees' wages, which will be funded with existing Police Bureau FY 2010/11 and FY 2011/12 General Fund appropriation within the Detective Division. There is no grant match requirement.
