

**ORDINANCE No. 184166**

\* Authorize a grant agreement with Raphael House of Portland to assist victims and survivors of domestic violence in an amount not to exceed \$50,000 per year for 5 years (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau responds to many calls involving domestic violence.
2. Victims of domestic violence frequently feel isolated with nowhere to turn for help and support.
3. Raphael House of Portland provides resources, support and assistance to victims, survivors, and children of domestic violence. Raphael House of Portland has been providing advocates for victims of domestic violence where weapons or threat of weapons are used.
4. Raphael House of Portland provides domestic violence advocates to aid victims of domestic violence through their guidance, safety planning, referrals and assistance to successfully navigate through the legal system.
5. The funds for this grant agreement were specifically included as an ongoing General Fund appropriation for the Police Bureau in the FY 2008-09 Adopted Budget in order to provide advocates for the victims and survivors of domestic violence.
6. The term of this agreement is July 1, 2010 through June 30, 2015 with a not to exceed amount of \$50,000 per year.

NOW, THEREFORE, the Council directs:

- a. The Mayor and City Auditor are hereby authorized to enter into a grant agreement substantially in accordance with the agreement attached as Exhibit A.

Section 2. The Council declares an emergency exists because delay in proceeding with this grant agreement will unnecessarily deprive the City, Raphael House of Portland and victims of domestic violence in Portland of the mutual benefits of this agreement. Therefore, this ordinance shall be in full force and effect from and after its passage by the Council.
