

ORDINANCE No. 184168

*Authorize an Intergovernmental Agreement with the Oregon Department of Transportation to receive \$495,000 grant from the Safe Routes to School Program for design engineering and construction of bicycle and pedestrian safety improvements at eight Portland public elementary schools. (Ordinance)

The City of Portland ordains:

Section 1. The Council finds

1. On July 25, 2007, Council approved Ordinance No. 181167 that authorized the Portland Bureau of Transportation to submit two applications to receive grant funding through Safer Routes to School Program, administered by the Oregon Department of Transportation.
2. On January 19, 2010, the Oregon Department of Transportation awarded the Portland Bureau of Transportation a Safer Routes to School grant to fund bicycle and pedestrian safety improvements at eight Portland public elementary schools.
3. The grant covers the total anticipated cost for engineering and construction of the project, estimated at approximately \$495,000.
4. The Bureau's level of confidence in the cost estimates for this project is low, because the project has not yet been engineered.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Transportation from the Safe Routes to School Program in the amount of \$495,000 and to execute an Intergovernmental Agreement in substantially the form of the attached exhibit for this purpose.
- b. The FY 2010/2011 budget is hereby amended as follows:

GRANTS FUND
Fund - 217
Business Area – TR00
Bureau Program Expenses - \$495,000
- c. The OMF Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

Section 2. The Council declares that an emergency exists because a delay would unnecessarily delay the City's ability to perform the activities authorized by the grant; therefore, this Ordinance shall be in full force and effect from and after its passage by Council.


