Estimated one-time and ongoing costs:

Estimated ongoing costs by Bureau (ongoing costs include repairs and maintenance, fuel and future replacement): Police has an interagency agreement with CityFleet for leased vehicles. This lease is included in the FY 2011 agreement between CityFleet and Police, and there is no increase in operations and maintenance associated with this request. The additional monthly costs for the upgraded SUV are estimated at \$166.

Parks requests are outside of the present interagency with CityFleet for FY 2011. The ongoing costs for the four new vehicles for the Bureau are estimated at \$968 per month.

Bureau of Transportation has requested eight new pieces of equipment that are not in the FY 2011 interagency agreement with CityFleet. The ongoing costs associated with this request are estimated to be \$22,902.

Water's request is estimated to cost \$1,252 per month in FY 2011.

Bureaus will not be charged for services until the units have been issued to the Bureau for use.

7. BACKGROUND ANALYSIS

CityFleet has reviewed the requests from PBOT-Maintenance, PBOT-Engineering, Parks, Police, and Water, and has determined that the vehicles requested are appropriate. PBOT-Maintenance is changing its operations to improve efficiency and reduce costs and their equipment requests are consistent with Council's direction to work on arterial streets. We request emergency status on this ordinance as a delay in proceeding with these purchases will result in additional expense for rentals, and will unnecessarily deprive the City of the use of these vehicles.

8. FINANCIAL IMPACT

Leases and Rental include a full-size sedan for Police (\$7,586) and a forklift for Water (\$4,500). The total of Lease/Rentals is \$12,086.

New additions for City bureaus include a utility trailer (\$1,545), a tilt trailer (\$3,500), and two ³/₄-ton pickups (\$35,000 each, \$70,000 for two) for Parks. Police need a mid-size sedan (no cost). Transportation Engineering requires two ³/₄-ton pickups (\$35,000 each, \$70,000 for two). Transportation Maintenance requires a cutter wheel (\$192,000), a crack seal machine (\$46,000), a small grinder (\$161,000), a trailer-mounted pressure washer (\$21,000), a 5x8 trailer (\$5,000), and a flatbed truck (\$91,000). Water needs a used trailer-mounted generator (\$57,500). New additions total \$718,545.

Upgrades are requested for Police and Water. Police needs a full-size SUV (\$14,000) and Water needs a 12-15 yard dump truck (\$70,000) and a Catch Basin Cleaner (\$120,000). Total for upgrades is \$204,000. Total for lease/rentals, new additions and upgrades is \$934,631.

9. RECOMMENDATION/ACTION REQUESTED

The Council declares that an emergency exists as a delay in proceeding with these purchases will result in additional expense for rentals, and will unnecessarily deprive the City of the use of these vehicles. Therefore, this Ordinance shall be in Full force and effect from and after its passage by Council.
