

ORDINANCE No. 184176

* Accept a grant in the amount of \$80,000 and appropriate \$33,000 for FY 2010-11 from the Oregon Department of Justice Crime Victims' Services Division for the 2010 VOCA Basic Grant to fund Police Bureau Crisis Response Team personnel (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. The Police Bureau applied to the Oregon Department of Justice Crime Victims' Services Division for a grant in the amount of \$80,000 for the 2010 VOCA Basic Grant on June 9, 2010.
2. The Oregon Department of Justice (ODOJ) has notified the City of Portland that it will award a grant for the 2010 VOCA Basic Grant to the Police Bureau in the amount of \$80,000.
3. The ODOJ will reimburse the City for approved personnel expenses for 0.75 FTE of the personnel expenses for the Crisis Response Team's Senior Administrative Specialist/Volunteer Coordinator for 24 months.
4. Local match in the amount of \$20,000 will be provided by funds from existing Police Bureau appropriation within North Precinct in FY 2010-11, 2011-12 and 2012-13.
5. The grant period is October 1, 2010, through September 30, 2012.

NOW, THEREFORE, the Council directs:

- a. The Mayor is hereby authorized to accept on behalf of the City of Portland a grant from the Oregon Department of Justice Crime Victims' Services Division for the 2010 VOCA Basic Grant in the amount of \$80,000.
- b. The FY 2010-2011 budget is hereby amended as follows:
GRANTS FUND
Fund - 217
Business Area – PL00
Bureau Program Expenses - \$33,000
- c. The Office of Management & Finance Grants Office is authorized to perform all administrative matters in relation to the grant application, grant agreement or amendments, requests for reimbursement from the grantor, and to submit required online grant documents on the Mayor's behalf.

d. The Chief of the Police Bureau of the City of Portland is authorized to accept on behalf of the City of Portland any subsequent modifications by the Oregon Department of Justice for the 2010 VOCA Basic Grant, #VOCA-NC-2010-00004, provided such modifications do not increase the City of Portland's financial obligation or risk. Any modifications that increase the City of Portland's financial obligation or risk must be authorized by the Portland City Council.


