1) Legislation Title:

* Accept a grant in the amount of \$80,000 and appropriate \$33,000 for FY 2010-11 from the Oregon Department of Justice Crime Victims' Services Division for the 2010 VOCA Basic Grant to fund Police Bureau Crisis Response Team personnel (Ordinance)

2) Purpose of the Proposed Legislation:

To accept a grant award from the Oregon Department of Justice (ODOJ) Crime Victims' Services Division for the 2010 VOCA Basic Grant to fund Police Bureau Crisis Response Team personnel. The \$80,000 award is for 24 months of which \$33,000 will be appropriated for FY 2010-11. The grant period is October 1, 2010, through September 30, 2012.

3) Revenue:

The ODOJ will reimburse the City for approved personnel expenses for 0.75 FTE of the personnel expenses for the Crisis Response Team's Senior Administrative Specialist/Volunteer Coordinator for 24 months.
