

ORDINANCE NO. 184187

* Authorize an Intergovernmental Agreement with Multnomah County for the implementation of Neighborhood Stabilization Program activities (Ordinance)

The City of Portland ordains:

SECTION 1. The Council finds that:

1. The Portland Housing Bureau (PHB) and Multnomah County (the County) are subgrantees of the Oregon Housing and Community Services (OHCS) administered Neighborhood Stabilization Program (NSP) grant and wish to cooperate in their activities.
2. PHB and the County have obtained the express written consent of OHCS to assign each of their rights and obligations under the NSP Subgrantee Agreements.
3. PHB has agreed to administer the County's entire NSP allocation of \$296,172 and the County is assigning the City its allocation of NSP administrative funds (\$23,693.76).
4. Funding from the County's NSP administrative and program allocations is included in PHB's FY 2010-11 approved budget in the amount of \$296,172.

NOW THEREFORE, the Council directs that:

- a. The Housing Commissioner and City Auditor are hereby authorized to execute agreements with the County for the amounts described above in accordance with the IGA attached as Exhibit A.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the PHB operating fund budget when demand is presented and approved by the proper authority.

SECTION 2. The Council declares that an emergency exists because delay in funding would interrupt these organizations' ability to provide assistance and services to low-income households; therefore, this ordinance shall be in full force and effective from and after its passage.




