Amend contract with David Evans and Associates, Inc. for additional work and compensation for the Argyle and 13<sup>th</sup> Lake Pump Station Remodel Project No. E08874 (Ordinance; amend Contract No. 38401)

### The City of Portland ordains:

#### Section 1. The Council finds:

- 1. The Bureau of Environmental Services (BES) has need of continuing professional engineering services provided by David Evans and Associates, Inc. for the completion of design and construction work for the Argyle and 13<sup>th</sup> PS Remodel, Project No. E08874.
- 2. David Evans and Associates, Inc. is providing professional engineering services under Contract No. 38401, effective on November 3, 2008 with an amended expiration date of June 30, 2012.
- 3. This Amendment 3 will authorize additional work in the amount of \$26,200 for a new not-to-exceed contract amount of \$196,675.
- 4. The estimated cost of this contract amendment is \$26,200. Funds are available in the Sewer System Operating Fund, FY 2011 Budget, Bureau of Environmental Services, Project No. E08874.
- 5. M/W/ESB participation after the authorization of this contract amendment will be \$17,000, 8.64% of the total amended contract amount of \$196,675.

#### NOW, THEREFORE, the council directs:

- a. The Commissioner of Public Affairs is authorized to execute an amendment to Contract No. 38401 with David Evans and Associates, Inc., in a form substantially in accordance with the amendment attached as Exhibit A, for the purpose described in Section 1.
- b. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the Sewer System Operating Fund Budget when demand is presented and approved by the proper authority.
