

ORDINANCE No. 184201

\*Accept Emergency Management Performance Grant FY 2010 Final Report by signing FY 2010 Certification of Completion (Ordinance)

The City of Portland ordains:

Section 1. The Council finds:

1. FY 2010 financial and technical assistance is provided through the Federal Emergency Management Agency's Emergency Management Performance Grant (EMPG). These funds are provided for the development of an all hazard emergency management capability to promote Performance, mitigation, response and recovery;
2. The EMPG FY2010 Certification of Completion and FY2010 Work Plan (Attachment A) states that the City of Portland Office of Emergency Management has completed the minimum required by the grant;
3. All funds received through the EMPG program will be provided on a reimbursable basis and will be matched 100% by City of Portland general funds;
4. Minimal basic requirements for participation in the EMPG program are
  - a. Coordinate and implement a local integrated Emergency Management System
  - b. Review and update emergency management plans, policies, guidelines and standard operating procedures
  - c. Exercise emergency operations plans
  - d. Attend a minimum of twenty hours of training
5. Grant funds are budgeted for one half of the cost of two management positions, one half of the annual rent for Portland OEM office space and one half of the total cost of situational analysis equipment at POEM offices.

NOW, THEREFORE, the Council directs:

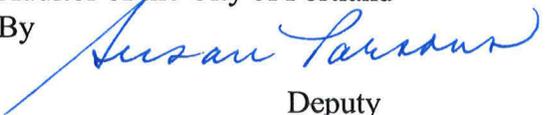
- a. The Mayor is hereby authorized to approve, by signature, the Fiscal Year 2010 Work Plan Certificate of Completion

Section 2. The Council declares that an emergency exists because delay in the Mayor signing the agreement would delay necessary funding allocated to the Portland Office of Emergency Management; therefore, this ordinance shall be in full force and effect from and after its passage by Council.
