To accept a grant award from the Oregon Association Chiefs of Police for the Oregon Association Chiefs of Police for the DUII Traffic Safety and the High Visibility Enforcement (HVE) enforcement grant program for personnel overtime. The \$50,000 award is for 12 months of which \$38,000 will be appropriated for FY 2010-11. The grant period is October 1, 2010, through September 30, 2011.
