**1) Legislation Title:** Accept a grant in the amount of \$1,958,651 and enter into a Grant Agreement with the Oregon Department of Transportation *ConnectOregon* III Grant program for Oregon Sustainability Streetcar Access Project (Ordinance)

**2) Purpose of the Proposed Legislation:**

Portland Bureau of Transportation (PBOT) applied to ODOT on November 20, 2009 for a grant in the amount of \$1,958,651 for the Oregon Sustainability Streetcar Access Project, which will build a dual streetcar track and improve the substandard pedestrian and bike environment at the site of the Oregon Sustainability Center. ODOT has notified the City of Portland that it will award a grant for the Oregon Sustainability Streetcar Access to PBOT in the amount of \$1,958,651. This legislation accepts the grant awarded for the project.
