## **RESOLUTION No.** 36833

Extend completion date for the Bureau of Transportation's Recommendations based on the Northwest Parking Plan adopted by City Council in 2003 (Resolution; amend Resolution No. 36744)

WHEREAS, on September 21, 2003, the Portland City Council adopted the Northwest District Plan; and

WHEREAS, The Northwest Parking Plan is contained within the Northwest District Plan as Policy 4: Parking; and

WHEREAS, on October 21, 2009, the Portland City Council readopted all portions of the 2003 Northwest District Plan that were either upheld or went unchallenged during appeals of the Northwest District Plan to the Land Use Board of Appeals and the Oregon Court of Appeals; and

WHEREAS, in Resolution 36744, adopted October 21, 2009, the Council directed the Bureau of Transportation to bring an ordinance to the Portland City Council by Fall 2010 that would create a meter and permit district, establish a meter fee, and create a Northwest Portland Transportation and Parking Management Association with an approved revenue allocation plan, pursuant to the Northwest Parking Plan adopted by Council in 2003; and

WHEREAS, The Northwest Parking Stakeholder Advisory Committee (the Committee) was formed and will assume responsibility for guiding the development of Northwest District Parking Plan and make their recommendations to Mayor Sam Adams once the work is complete; and

WHEREAS, the efforts this past year have focused on establishing the Committee and working with that group to develop a common understanding of the district's parking issues and the best practices for addressing those issues; and

WHEREAS, Mayor Sam Adams directed that an analysis of economic indicators be completed to insure that the implementation of new parking management measures do not have a detrimental impact on economic vitality or community livability; and

WHEREAS, the Committee examined demographic, employment, business and real estate trends influencing the district to understand the higher purposes that parking serves in this district; and

WHEREAS, the Committee additionally studied industry best practices for parking management and thoroughly reviewed past Northwest District parking plan efforts in order to model the parking plan on the best practices of parking management and build on the lessons of previous parking management planning efforts; and

WHEREAS, the Committee also developed goals and objectives for the parking plan and protocols to govern their group process, thereby establishing a strong foundation for the next stage of the committees work.

NOW, THEREFORE, BE IT RESOLVED that the timeline to have the Bureau of Transportation return to Council as specified in Resolution 36744 is extended and the Bureau of Transportation is directed to bring an ordinance to the Portland City Council by Fall 2011 that will create a meter and permit district, establish a meter fee, and create a Northwest Portland Transportation and Parking Management Association with an approved revenue allocation plan, pursuant to the Northwest Parking Plan adopted by Council in 2003.

BE IT FURTHER RESOLVED, that no other proposed amendments to the readopted Northwest District Plan or Northwest Parking Plan are contemplated or intended by adoption of this Resolution.
